

6 Week Session Class Descriptions

All classes below are subject to class minimums

Kindersteps™ I (Ages 2-3)

This class, taught by Ms. Cathy, teaches basic motor, dance and social skills in a fun and nurturing environment using movement, music, instruments and a variety of equipment.

*Wednesdays 10:15 - 11:00 am

Kindergym I/II (Ages 2-4)

This class, taught by Ms. Cathy, teaches basic motor and social skills and slowly introduces more specific sport skills in a fun and nurturing environment using a variety of equipment and toys.

*Tuesdays 10:15-11:00 am

Yoga Kids I (Grades 1-3), II (Grades 4-6)

This class offers a fun and relaxing mind and body experience geared just for kids. Children will learn individual yoga poses as well as partner and group poses and games in a fun, non-competitive environment. Visual imagery and relaxation exercises will be used to help kids reduce stress.
